For Dual Citizenship Applicants

1. Duly accomplished Petition for Dual Citizenship form (can be downloaded from www.chicagopcg.com)
2. Photocopies of required documents
3. Corresponding fees (money order/cashier's check payable to the Philippine Consulate General)
4. Self-addressed stamped envelope (Certified Priority Mail/Express Mail/FEDEX/UPS/DHL)
